Sponsors of proprietary centers must demonstrate that each for-profit center participating in the Child and Adult Care Food Program is in compliance with the following:

- Provides nonresidential child care services for which it receives compensation from amounts granted to the States under Title XIX / XX of the Social Security Act, and that
- Title XIX / XX\_or Free and Reduced child care beneficiaries constitute no less than 25 percent of enrolled eligible participants or licensed capacity, whichever is less.

Therefore, the Child and Adult Care Food Program requires that sponsors of proprietary (for-profit) center(s) annually certify that each center is in compliance with program requirements.

NOTE: Sponsors may <u>not</u> combine the number of participants receiving Title XX support with the number participants within the free or reduced price eligibility criteria in order to meet the 25 percent threshold.
